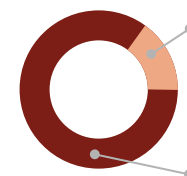

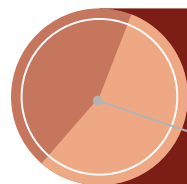

A Place to Call Home

The Chamber operated out of Danielsville's Historic Courthouse until the summer of 2020 when the structure suffered severe water damage. Our organization is grateful to have been temporarily housed at the Madison County Board of Education for nearly four years. We are proud to announce that in 2024, we officially moved headquarters to the R.G. Strickland House in historic downtown Danielsville. This opportunity to once again have a central physical presence in our business community would not have been possible without the generosity and vision of Tripp Strickland.

The R. G. Strickland House has been a cornerstone of downtown Danielsville for over 150 years. Built around 1860 in the Carpenter Gothic style, the house was owned by Dr. Sorrells until Mr. Leonidas Eugene Greene Sr. bought it in 1896.

Mr. Greene renovated and added onto the home, expanding the half-floor upstairs to a full second story and adding multiple rooms, including the dining room and kitchen areas. These additions included the staircase in the foyer and the Victorian elements of the house, as was the style of the time.

Since then, the building housed multiple generations of the Greene family until it was purchased and renovated by Mr. Tripp Strickland. The house is named in his family's honor, and the conference room is named after his father, Mr. George Strickland, Jr. He was a pillar in our business community and recognized in 2021 as our Chamber's Lifetime Achievement award winner.

Proud of his county and wanting to support the positive change the Chamber is bringing to the community, he donated the R.G. Strickland House for members and partners as a catalyst for economic and community development.

Georgia Grown Trail 98: PAVING THE WAY FOR REGIONAL AGRITOURISM

We were thrilled to collaborate with local legislators, Banks County Chamber of Commerce and CVB, City of Commerce Development Authority, Jackson County Chamber of Commerce, Georgia Department of Agriculture, LEM Ag Marketing and Jackson EMC to officially designate a portion of Georgia Highway 98 as Georgia Grown Trail 98. This designation is the first of its kind in northeast Georgia and serves as a tool for both locals and tourists to explore the rolling hills from Homer to Comer along a route that highlights agriculturally related tourism sites, included but not limited to, u-pick farms, farm and farmers markets, vineyards and wineries, breweries and distilleries, restaurants using local and regional products, specialty stores with a selection of Georgia food/ag products, farm tours, agricultural-related events, and more.

What evolved into a regional partnership with Banks and Jackson Counties was originally cultivated out of necessity in 2020 within the Chamber's Agricultural Promotions Committee. Covid-19 brought about a resurgence in consumers desiring locally sourced food. We worked with local agribusiness partners and the University of Georgia Extension Service to compile a list of local producers who were selling directly to consumers. This local branding effort gained so much traction that it ultimately became branded as MADICO MADE, the Chamber's key marketing initiative that aims to celebrate the people, places, and products that make Madison County unique.

Georgia Grown Trail 98 only amplifies this effort because it works with regional partners to promote the assets that strengthen our local economy and give us a competitive advantage at the state and regional level.

MADICO Flex Fosters Students Entrepreneurship

The Foundational Leadership and Entrepreneurship Experience (FLEX) is an entrepreneurship program for high school students that engages them in the business world through experiences and mentorships. Students in FLEX create real businesses, provide real products and services, and make real money. Local business partners, along with community leaders and teachers help to make this program a success. Our local champions invest in the program through teaching workshops and mentoring student entrepreneurs. Students compete in three rounds of competition until a local winner is selected. Local FLEX champs then move on to the state-wide competition.

A \$5,000.00 donation from SunTrust and a \$15,000.00 donation from Georgia Power positioned Madison County to become among the first in our region with a local FLEX program, MADICO FLEX. We currently have seven Madison County High School students participating in our inaugural MADICO FLEX program.

Much like Georgia Grown Trail 98 was rooted in a Chamber committee, MADICO FLEX originated out of the Chamber's Workforce Development and Education Committee when school system leadership and local business and industry partners identified a need to foster student entrepreneurship in Madison County. This initiative is gaining traction in our community thanks to the tireless capacity building efforts by Madison County High School and the Broad River College and Career Academy as they prepare high school students for the workforce.
